You, ASI(UB)/695 Ashok Kumar Das of Chandannagar Police Commissionerate, last posted at Chandannagar Court, now under suspension, are hereby charged with indiscipline conduct and moral turpitude unbecoming of a member of disciplined Police force 1. While you were attached to Chandannagar Court, a report has been received against you from Inspector-in-Charge, Station, Chandannagar Police Commissionerate dated 15.04.2025 that a written complaint had been received from the complainant Mousumi Bhowmick w/o Sanjoy Bhowmick, Padmabati Colony, Baidyabati, Hooghly to the effect that her father-in-law namely Tarak Bhowmick went to open his tea stall in front of Yuba Milan Parishad Club, Padmabati Colony, PO-Baidyabati, PS - Serampore on 14.04.2025 at about 04.30 hrs. At about 04.45 hrs. she received an information that some unknown persons came in front of the said tea stall and forcibly picked her father-in-law in a white colour vehicle and left the place. Later at about 06.00 hrs. on that day, she received a telephonic call, demanding a ransom of Rs. 30 (thirty) Lakhs in her father-in-law's contact number (7439018892). Over this issue a specific case was started vide Serampore PS Case No. 210/25 dated 14.04.2025 U/S 140 (2) BNS and the investigation was started. During prima facie investigation it was found that you were involved in this case. Your such conduct is unbecoming of a public servant and in violation of Rule 3/4 of the West Bengal Government Servants' Conduct Rules, 1959 and Rule 24 of PRB.1943.
