FINAL ORDER

HOWRAH POLICE COMMISSIONERATE PROCEEDING NO 24/2024 DATED 26.11.2024 DRAWN UP AGAINST SUB-INSPECTOR (UB) IMRAN ALI OF CHANDANNAGAR POLICE COMMISSIONERATE (EARLIER OF HOWRAH POLICE COMMISSIONERATE).

The instant proceeding was drawn up against SI (UB) Imran Ali of Chandannagar Police Commissionerate charges with gross misconduct and dereliction of duty unbecoming of a member of disciplined police force in that:-

During his incumbency at Malipanchghora PS, Howrah Police Commissionerate, it is ascertained from the report of Anudvuti Maiumdar. Officer In-charge. Shri Malipanchghora PS, Howrah PC which was duly forwarded by Deputy Commissioner of Police (North Division), Howrah PC vide Memo No.- 4261/DCP (ND)/HPC/2024 dated 18.11.2024 that as per direction of Jt. Commissioner of Police, Howrah PC, on 15.11.2024, a team was to be dispatched to Chopra, Uttar Dinajpur, to investigate Cyber Fraud Tab cases. In the meantime, as directed by DCP (ND), HPC he was instructed by OC Malipanchghora PS to join the team which was being led by the OC, Cyber Crime PS, HPC. But he blatantly refused to comply with OC's direction and also he stated that, "Ami jete parbona, tar jonno jodi punishment khete hoy, khabo". His such behavior clearly shows insubordination and a complete disregard of official orders. Also his actions demonstrate a lack of professional conduct and respect for Superior's order.

Thereafter, on 16.11.2024, while performing RT mobile duty, he informed OC, Malipanchghora PS that he needed leave on 17.11.2024 to attend the engagement ceremony of his sister-in-law. Though he had already availed CL from 09.11.2024 to 13.11.2024 and other officers of Malipanchghora PS also need to be granted leave in turn. Despite this reminder of OC, Malipanchghora PS, he arrogantly insisted that he would attend the ceremony regardless of the consequences. This amounts to gross indiscipline behavior on his part.

Later that night, he reported sick and claimed to have sought treatment at Jaiswal Hospital, where he was advised three days of rest, which was communicated by him through Malipanchghora PS email. On 17.11.24 morning, as per instruction of OC Malipanchghora PS, SI Amit Paul of Malipanchghora PS went to verify his health condition but he was not found at PS barrack. Finally SI Amit Paul called him over phone and he informed him that he left for his residence without informing anyone. This has been recorded in Malipanchghora PS GDE No. 688 dated 17.11.2024. His such behavior not only disrupts the internal administration of the Police Station but also sets a poor example for other officers, potentially encouraging similar acts of indiscipline.

Thus he violated the Section 23 of Police act (Act-V of 1861) and liable to be prosecuted u/s 29 of Police Act (Act V of 1861). He also violated the Rules 3 & 4 of West Bengal Government Servants' Conduct Rules, 1959.

The copy of Charge along with the Statement of Allegations and the copy of exhibit documents were served upon the Charged Officer on 02.12.2024. The Charged Officer submitted his written explanation on 19.12.2024 wherein the he pleaded guilty to the charge, prayed for mercy and did not prefer any open enquiry. It appears nothing more will be yielded in open enquiry.

The departmental proceeding file along with relevant papers has been sent to Chandannagar Police Commissionerate vide memo. No.1667/RO dated 05.06.2025 for completion of said departmental proceeding as the Charged Officer posted at Chandannagar Police Commissionerate from Howrah Police Commissionerate.

After that it is decided to conclude the proceedings without dragging it through open enquiry. Accordingly, the Charged Officer was called upon for personal hearing on 16.06.2025. I heard the Charged Officer personally. During personal hearing the Charged Officer again pleads his guilt and prayed for mercy and said that he would rectify his conduct and also stated that he will not repeat his mistake again in future.

I have gone through the proceeding file minutely. The Charged Officer was refused to comply with OC's direction and left for his residence from PS during his sick rest without informing anyone. His such unprofessional activities are not befitting of a police officer and highly detrimental to the discipline of police department.

Before passing final order, I have also taken into consideration the general character of the Charged Officer in the light of his past service career. Till date he has been awarded 08 (eight) rewards in his credit, 03 (three) E.O.L.s and no major/minor punishments against him during his past service.

Having gone through the evidences on record and having applied my judicious mind, I am of considered view that the Charged Officer is guilty of the charges drawn up against him. However, considering all aspects including the present stage of service of the Charged Officer I am not taking any lenient view.

Hence I, ordered that one increment of pay of the Charged Officer SI (UB) Imran Ali of Chandannagar Police Commissionerate (now deputed at STF, WB) is withheld for a period of 06 (six) months w.e.f. 01.07.2025 as punishment which shall have no cumulative effect in his future increment and pay.

The Charged Officer may prefer appeal against the Final Order before the appellate authority through the undersigned within 37 days on receipt of the Final Order as per provision of Rule 883 of P.R.B. Vol-I.
